Bikers for Sight, presented by PA Biker Lawyer, is a motorcycle poker run through the Pocono Mountains' autumn splendor led by the Northeast PA Inter Club. All motorcycle clubs from all areas are welcome. Proceeds benefit Sights for Hope – a nonprofit organization that expands opportunities for people with visual impairments and blindness in Monroe County and the Lehigh Valley and promotes healthy eyesight. Bikers for Sigh was inspired by a Sights for Hope client who rode frequently before losing most of her vision.



The run begins at Pocono Mountain Harley-Davidson in Tannersville, PA, and ends at Blue Ridge Estate Vineyard & Winery in Saylorsburg, PA. The finish line tent will include food, wine for purchase, a tricky tray raffle, and chances to find out about what Sights for Hope does in its communities. Dear Sir or Madam:

We're responding to your request dated April 15, 2021, about your tax-exempt status.

We issued you a determination letter in September 1951, recognizing you as tax-exempt under Internal Revenue Code (IRC) Section 501(c)(3).

We also show you're not a private foundation as defined under IRC Section 509(a) because you're described in IRC 170(b)(1)(A)(vi).

Donors can deduct contributions they make to you as provided in IRC Section 170. You're also qualified to receive tax-deductible bequests, legacies, devises, transfers, or gifts under IRC Sections 2055, 2106, and 2522.

In the heading, we indicated whether you must file an annual information return. If you're required to file a return, you must file one of the following by the 15th day of the 5th month after the end of your annual accounting period.

According to IRC Section 6033(j), if you don't file a required annual information return or notice for 3 consecutive years, we'll revoke your tax-exempt status on the due date of the 3rd required return or notice.
